AUTOMATIC ASSET BUILDER

This service transfers funds from your bank account into almost any Fund, according to the amount and schedule you choose from available options.

To start a disciplined investment program, complete the form, enclose a voided check from the bank account to be debited and then mail to the address provided on the form.

- You don't have to remember to write a check, and there's nothing to address, stamp or mail.
- Make current-year, no-fee contributions to certain IRAs as well as non-retirement mutual fund accounts.
- Set your own pace: from \$100 to \$150,000 per transfer.
- Choose a convenient schedule: monthly, twice a month, quarterly, twice a year or annually on any date you designate.
- Your bank account is debited for each transfer, and you will be notified each time you add to your Fund.
- Funds are transferred electronically, so your bank must be a member of the Automated Clearing House (ACH).
