# **VETERANS DAY**

In observance of the upcoming Veterans Day holiday, the Dreyfus money market funds will be following the trading schedule below.

### Monday, November 10, 2025

- All money market funds, including the BNY Mellon Liquidity Funds plc, will trade their normal schedule.
- The Dreyfus Domestic Money Market Funds listed on page 2 below will issue a 1-day rate for Monday, November 10<sup>th</sup>, since the Dreyfus Domestic Money Market Funds will issue a one-day rate on Tuesday, November 11<sup>th</sup> - the day of the holiday - as indicated below.
- The **BNY Mellon Liquidity Funds plc, ("two offshore money market funds")** listed on page 2 below, will issue a **2-day rate** inclusive of Monday and Tuesday, since these two offshore money market funds **will not** issue a one-day rate on Tuesday, November 11<sup>th</sup> the day of the holiday as indicated below.
- BNY Institutional Services will be open normal hours.

#### Tuesday, November 11, 2025

- Since the New York Stock Exchange is open and the Federal Reserve Bank is closed, only next day settlement funds will be open for trading.
- There will be no trading in Money Market Funds for same day settlement, which includes all Dreyfus Domestic Money Market funds as well as the two offshore money market funds.
- Although there will be no Money Market Fund trading for same day settlement on Veterans Day, a
  price, rate and yield will be issued for all Domestic Money Market Funds on November 11, 2025.
- However, a price, rate and yield <u>will not</u> be issued for the two offshore money market funds on November 11, 2025.
- BNY Institutional Services will be open normal hours.

#### Wednesday, November 12, 2025

- All money market funds, including the BNY Mellon Liquidity Funds plc, will trade normal hours.
- BNY Institutional Services will be open normal hours.
