14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ On January 19, 2018, Dreyfus/TBC Small Cap Value Fund acquired all of the assets and assumed all of the liabilities of the issuer solely in exchange for shares of beneficial interest. (Details below) The merger of Dreyfus Small Cap Equity Fund into Dreyfus/TBC Small Cap Value Fund qualifies as a tax-free reorganization under Section 368(a)(1)(C). The Target shareholders' total basis in the Acquiring shares received is the same as their total basis in the old Target shares. Per share, each new Acquiring share received in the reorganization will have a basis equal to 100% of the Target share surrendered.

The exchange is based on the number and value of shares outstanding at the close of business on January 19, 2018.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ _____

A shareholder's aggregate basis in Dreyfus/TBC Small Cap Value Fund they received in exchange for their share of Dreyfus Small Cap Equity Fund will be the same as their aggregate basis in the shares of Dreyfus Small Cap Equity Fund. The number of Dreyfus/TBC Small Cap Value Fund shares that were received for each share of Dreyfus Small Cap Equity Fund given up in exchange is as follows:
