Estimated capital gains may be comprised of short and long-term gains and do not include ordinary income distributions. **Enclosed are final estimates, however they may change prior to final distribution dates based on several factors, including portfolio changes, tax adjustments, and changes in outstanding fund shares.**BNY Mellon funds not listed below are not currently projected to distribute a year-end capital gain as of the estimate date; however, that may change and you may wish to recheck our web posting for any updates.
