
An internet-based application that provides institutional and intermediary users with self-service access to account information, money market fund transaction processing, reporting and seamless interaction with the Dreyfus website.






Access Dreyfus LION

Please complete Lion User Access Form to obtain a new user ID and password:

- Upon your first-time logging in, you will be required to change your password from your initial default password
- Verify your identity by entering the one-time password that will be sent to your email on record upon your login
- Choose the option to register your device for future use without having to authenticate your device each time
- You will be prompted to agree to the terms of the online user agreement







Balances

Transactions

Perform multiple transactions on a single transaction screen

Transaction Types

Purchase

By dollar amount

Redeem

- By dollars, shares or percent of account
- User can also choose a full redemption with the option to include the dividend accrual

Exchange

- Into an existing fund and/or a new fund within an existing account
- By dollars, shares or percent of account. Full exchange will include the month-to-date dividend accrual

Transfers


- From one existing account to another in the same fund
- By dollars, shares or percent of account
- User can also choose a full transfer with the option to include the dividend accrual

Dividend Accrual Debit

- Redeem by dollar amount
- Redeem a full dividend amount

Transaction Upload

Upload bulk trading transactions in one easy step.


Please Note: Before using this feature, please contact the Institutional Service Desk at 1-800-242-8671 for training and for obtaining the file format to be used for this feature.

Trades are added to a queue for review before submission

- 1. Can be modified or deleted
- 2. Once reviewed, submit transactions.

All pending transactions in your queue not submitted will be deleted. Note, Dreyfus LION will time out after 20 minutes of inactivity.

3. Download a transaction confirmation






Transaction Approval

Optional functionality allowing additional oversight/approval prior to trades being submitted.

- Transactions remain pending until approved by authorized approver on record (per user access form)
- User's trades will be displayed on approval status screen with transactions status and the list of approvers
- Approvers will be notified by email of trades requiring approval with message that transactions will not be executed unless approval is provided
- Approvers can access trades through transaction approval
- 5. Approved trades are submitted
- 6. Rejected trades are deleted


Users with trade approval access are responsible for accepting or rejecting transactions submitted by their colleagues. These transactions will not be submitted for processing unless accepted by a designated approver. A user cannot approve transactions that they themselves have submitted. Transactions requiring approval must be approved prior to a Fund's trading deadline, as stated in the Fund's prospectus, in order to be considered in good order.





Account **Management**

- 1. Create a new money market account
- 2. Add a new money market fund to an existing account

Transaction History

View detailed history of all transactions by fund and account

Rates

View current and previous Dreyfus/ BNY Mellon money market fund pricing information

Maintenance History

View history of changes to an account setup

Account Information

View a snapshot of an account profile

Balance


- View prior day business day account positions
- Robust reporting at dealer, branch, fund and account level


Pending Trades

View all transactions submitted for a specific fund and account within the current business day

Same Day Trade

View transactions submitted for the current day that are linked to the user









Estimated Daily Dividend Accrual

View estimated daily dividend accrual based on the account share balance with the ability to customize the date range. Report results can be cumulative.

Wire Address

View wire redemption address(es) associated with each of their specific fund accounts.




Statements

Ability to choose multiple accounts










Messaging

- Send Institutional Services a freeform message and/or a large trade notification within the Dreyfus LION application
- 2. Ability to flag messages and large trades that are acknowledged (approved or denied) will appear in the large trade acknowledgment folder

Notification categories include:


- Fund action







